The Government COVID-19 catch-up premium has been established to mitigate the effects of the unique disruption caused by coronavirus. The grant is available for 2020-2021 academic year.

Schools should use this funding for specific activities to support pupils to catch up for the lost teaching time over the previous months. To support schools to make the best use of the funding, the Education Endowment Foundation (EEF) has published a support guide:
